Privacy Policy Statement

At Zara Multitraders we make securing the privacy of our Clients' financial and personal information a top priority. Please read the below Privacy Policy Statement, which clearly explains how we, at Zara Multitraders collect, process, store and secure our Clients' data. By opening an account, the Client hereby consents to the gathering, processing, storage and utilization of personal data by Zara Multitraders as delineated below.

Collection of personal data

Zara Multitraders collects the necessary data for the opening of your account, the execution of transactions and the protection of your assets and your privacy, so as to provide you with the services you require. To this end, Zara Multitraders gathers information from the Client and may, under certain circumstances, gather information from relevant banks and/or credit agencies, and/or other sources, to help us profile your requirements and preferences, and provide you with better services.

The data Zara Multitraders collects may include:

Application information

Personal information you supply in your application form, such as your name, address, birth date, email address, income and income source etc. in order to facilitate in the evaluation of your application. The data you supply is also used for the purpose of communicating with you.

Transaction information

Information about the anticipated volume and value of your transactions with us, and income data provided so as to enable the construction of your economic profile.

Verification information

Information necessary to confirm your identity, such as an identification card, passport or driver's license. This also includes background data we receive about you from public records or from other bodies not affiliated with Zara Multitraders.

Usage of personal information

Zara Multitraders only uses your personal data as necessary, for guaranteeing your security and providing you with quality service. This data helps us improve services, tailor the browsing experience, inform you of additional, relevant products, services or promotions, and provide the products and services you require. do so could result in Zara Multitraders being unable to open your account or to provide you with the services you require. Whilst we endeavor to ensure that all the information we hold about you is current, accurate and complete, we urge you to contact us directly if any of your personal details have changed.

Protection of personal data

Any personal data you provide will be treated as confidential and will only be shared within Zara Multitraders and its affiliates. It will not be disclosed to any third party except in the case of regulatory or legal proceedings. The personal data that you provide in connection with registering as a user of Zara Multitraders.com is protected in a number of ways. You can access your registration data through a password selected by you. This password is encrypted and known only to you. It shall not be revealed to anyone else. Registration data is safely stored on secure servers that can only be accessed by authorised personnel via password. Zara Multitraders encrypts all personal data as it is transferred to Zara Multitraders, and thus makes all necessary effort to prevent unauthorised parties from accessing any such information.

Affiliates and partners

Zara Multitraders may share information with partners, affiliates and alliances in the case that such information may be reasonably required by such an affiliate, in order to: offer additional similar products and services, which meet your requirements, and are delivered in a useful and relevant manner (only where you have authorized us to do so); and/or service customer accounts.

Non-affiliated third parties

Zara Multitraders does not sell, license, lease or otherwise disclose personal data to third parties, except as outlined in this Privacy Statement Zara Multitraders reserves the right to disclose information, as necessary, to credit reporting or collection agencies, as reasonably required in order to provide the services to you. To assist us in improving our services, Zara Multitraders may engage third parties to help carry out certain internal functions such as account processing, fulfilment, client service, client satisfaction surveys or other data collection activities relevant to our business. Use of the shared data may also be used to provide professional, legal, or accounting advice to Zara Multitraders. Use of shared information is strictly limited to the performance of the above and is not permitted for any other purposes. All third parties with which Zara Multitraders shares personal information are required to protect such personal information in accordance with all relevant legislation and in a manner similar to the way Zara Multitraders protects the same. Zara Multitraders will not share personal information with any third parties that it considers will not afford its Clients the required level of protection. Where you have been introduced to us by a Business Introducer, such Business Introducer may have access to your information. You hereby unambiguously and unequivocally consent to the sharing of information with such Business Introducer.

Regulatory disclosure

Zara Multitraders reserves the right to disclose personal information to third parties where required by law, regulatory, law enforcement or other government authority of a competent jurisdiction Republic of Mauritius, in order to protect our rights and/or to comply with such legal proceedings. Such disclosure shall occur on a 'need-to-know' basis, unless otherwise instructed by a regulatory or other government authority
